## TUITION RATES: 2017-2018

Initial to verify you have read the following statements. Payment of applicable fees are required to secure a seat in the classroom for next year. New students may submit an application and all accompanying non-refundable fees, but will be placed on a waiting list until **March 1, 2017**.

- 1.) \_\_\_\_\_ (initials) **MULTIPLE STUDENT DISCOUNTS:** The oldest student pays full price; the remaining student (s) will pay the amount listed under the total student category listed below.
- 2.) \_\_\_\_\_ (initials) **PAYMENT IN FULL DISCOUNT:** If tuition and fees are paid in full by **July 28, 2017** you will receive a 5% discount on your tuition.
- 3.) \_\_\_\_\_ (initials) **WITHDRAWAL FEE:** After you re-enroll/ enroll, you have until **July 28, 2017** to withdraw, with only a fee of  $\frac{1}{4}$  of the annual tuition for the student's grade level being charged. If you withdraw after **July 28, 2017**, you will be charged the full quarter(s) amount according to the date you withdraw plus any fees incurred by the school for your child(ren).
