IT'S RE-ENROLLMENT TIME

In your family packet is the blue re-enrollment form for 2019-2020 school year. YES, it IS that time of the year again. By filling out the form **and** sending in the \$100 enrollment fee, you will secure your child's spot in their grade before enrollment opens to the public. Both form **and** enrollment fee are required to hold spot. Keep in mind that open enrollment begins on March 1, 2019 and the enrollment fee increases to \$200. The Church Attendance form is on the back of the re-enrollment form. Please make sure you fill that out also before sending it in.

Re-enrollment Process:

1. Complete Re-enrollment Form (initial 3 statements at the top and back) and return to the office with \$100 re-enrollment fee by March 1st.
2. You will receive a copy of your 2019-2020 Invoice with Payment Methods on the back. Choose your method of payment, sign, and return to the office. Reenrollment is NOT complete till this step is completed.
3. In mid-April you receive an email to complete re-enrollment forms via RenWeb for the 2019-2020 school year. These are to be completed by Friday, May 24th.
